2020 Membership Agreement

In order to ensure the sustainability of Thermopolis Golf Course, please note and abide by the following season pass rules and guidelines.

ALCOHOLIC BEVERAGES: Any alcoholic beverages consumed on the course must be purchased on-site at the pro shop or restaurant/bar. Adherence to this rule is required by our insurance company and the State along with the contractual obligation with the restaurant lessee.

ANNUAL CART RENTAL: Annual rental fee entitles you to the use of one cart at a time, in accordance with your membership level. For example, if you purchase a Couple Season Pass, the member or spouse may use the cart. There is no additional cost if one spouse takes a rider on the cart in this example.

PRIVATE CART STORAGE or TRAIL FEE: These annual fees are in accordance with your season pass as well. If you pay for cart storage and have purchased a Family Season Pass, any member of your family covered under the pass may take the cart onto the course, and may take a rider outside your season pass group. If you have a Single Season Pass, only you can take the cart onto the course. If you give permission to anyone outside your membership group to use your private cart, Trail Fees must be paid by that person. If a private cart is jointly owned and Private Cart Storage or Trail Fees are paid for that cart, each additional party must pay additional Trail Fees (either annual fee or per round) in order to take the cart onto the course.

LOCKER RENTAL: Locker rental fees must be paid before being allowed to attach a personal lock on the locker. Please be sure to remove your lock and clear out your locker at the end of the season. The locker room will be locked on November 1, 2020.
